



- Transparency
- ❖ Time limit

Stages or status

Stage	Description
Pre-Application	Meeting for mutual understanding Appropriate documentation are exchanged.
Preparation	Filling application form + technical guidance Permit register record open (keep discussions, telephone and correspondence)
Application	If admissible → checklist If not admissible → advice and appropriate actions
Consultation	Other authorities and public are consulted Public notice (except if confidential)
Assessment	Permit team assessment
Approval	Approved by each level of authority
Issuance	Issuance or refusal Renewal process



Transition

- Implementation strategy
- ■Scope → List of industrial sectors, Inventory of installations
- Help industries to manage the changes
- ■Set priorities → more impact
- Institutional and legal aspect
- Prepare human resources and \$
- Pilot project

Integration of authorities





Flowcharts of the Permitting Procedure and monitoring in the system












